Ollyguide Terms and Conditions

1. Your booking must be accompanied by a deposit of 50% of the trip cost per person, or if booked within 42 days (6 weeks) of the trip start date by the full payment. This deposit is non-refundable if you choose to cancel. When Ollyguide has received payment and checked all information contained within your booking form, your booking will be accepted. You will then be sent a booking confirmation receipt, together with further course information.

2. Balance of payment is due 42 days (6 weeks) prior to the course start date. Ollyguide prefers you to pay the full balance by a direct bank transfer or cheque. If full payment is not received by this date Ollyguide reserves the right to cancel your booking without refund.

3. For courses taking place outside the United Kingdom you must purchase specialist mountaineering/ski insurance covering helicopter rescue, medical treatment and repatriation. You are required to send a photocopy of your insurance certificate when you make final payment.

4. If you wish to cancel you must notify Ollyguide in writing or by email, where upon the following charges will be applied from the date they receive your notice of cancellation: More than 6 weeks (42 days) before start date - loss of deposit. Between 4 and 6 weeks (28-42 days) before start date - 50% of course fee or loss of deposit, whichever amount is greater. Less than 4 weeks (28 days) before start date - full course fee.

5. If Ollyguide has to cancel a booking he shall refund all monies or the client can re-book on a different date or course. If Ollyguide cancels a course he will not be liable for any expenses which you may have incurred as a result of your booking or in expectation of the trip taking place.

6. Whilst Guides maintain high professional standards of client care and safety, you must realise and accept that mountaineering, skiing and climbing are activities which carry a danger of personal injury or even death, as they can take place in remote and potentially hazardous mountain terrain. All clients must be aware of and accept these risks and be responsible for their own actions and involvement in such activities.

7. All information contained within the Ollyguide website and other publicity is for guidance only. Whilst making every effort to ensure accuracy, Ollyguide cannot be responsible for any inaccuracies or alterations beyond his control.

8. Although Guides adhere to planned itineraries wherever possible, changes may occur to both travel and guiding itineraries due to external factors beyond their control. In particular, the Guide has total discretion to alter programs at any time in the interests of client safety, mountain or weather conditions. In the event that changes are made to the itinerary any extra costs will be met by the client.

9. If you have a complaint about the Guides service you receive at any point during the course, you must notify the Guide involved as soon as possible to give them the opportunity to rectify the situation to a mutual agreement. If the complaint is unresolved to your satisfaction during the trip put the details in writing within 28 days.

10. All terms and conditions between clients and the Guide are to be governed by and held under the exclusive jurisdiction of English Law.

11. By making your booking it implies that you understand and accept the booking conditions and agree to abide by them. The person booking the course must ensure that other participants read and accept these conditions.
